- Minimum age: 16 years

ABE Level 4 Foundation Diploma in Business Management

For those starting their business studies journey.

Entry Requirements:

- KCSE Grade C- (minus) and above
- "A" Level Certificate with 2 passes

- Equivalent qualifications recognised by ABE

ABE Level 4 Diploma in Business Management

Builds on the Foundation Diploma with deeper specialization.

Entry Requirements:

- KCSE Certificate with minimum Grade C
- "A" Level Certificate with 2 passes
- Equivalent qualifications recognised by ABE

Equips learners with strategic and practical management skills.

Entry Requirements:

- ABE Level 4 Diploma
- Equivalent qualifications accepted by ABE
- International Business Economics and Markets (E)

ABE Level 6 Diploma in Business Management

Designed for aspiring senior managers and leaders.

Entry Requirements:

- ABE Level 5 Diploma
- OR: Over 21 years old with at least 3 years' business experience
